 - a. Shavina's comments:

 - iv. Jackson has 54 staff members all together including office staff and maintenance.
 - v. Teacher incentive program SWAG bucks for teachers to get teachers motivated to do their best. Lunch with administration. Dress down pass. Teacher of the week Parking spot in front row. This has been effective.

 - i. More one on one and counseling to students.
 - ii. Ordered headphones for students to listen to things on their computers for a quieter work environment.
 - iii. New copiers are installed.
 - iv. Glitch with supplies, using a ton of paper.
