

**RESOLUTION OF THE BOARD OF ROCKFORD CHARTER SCHOOL  
ORGANIZATION AUTHORIZING JACKSON CHARTER SCHOOL TO SUSPEND  
MIDDLE SCHOOL CURRICULUM PROGRAM SERVICES**

WHEREAS, Rockford Charter School Organization (“RCSO”) is an Illinois not-for-profit corporation organized in the State of Illinois; and

WHEREAS, RCSO has a duly established Board of Directors; and

WHEREAS, on April 14, 2015, RCSO entered into an agreement with the Board of Education, Rockford School District No. 205 (“RPS 205”), Winnebago-Boone Counties, Illinois titled “Restatement and Extension of Charter School Agreement Between the Board of Education, Rockford School District No. 205, Winnebago-Boone Counties, Illinois and CICS Rockford Charter School” (hereinafter referred to as “Agreement”); and

WHEREAS, pursuant to Section 4, Educational Program, Subsection b, Age, Grade Range of the Agreement states as follows:

The Charter School shall provide instruction to pupils in grades K through 12, as provided in the Application.

WHEREAS, Jackson Charter School currently serves as a grades K through 8 school and has never operated grades 8 through 12 and has no plans to do so in the future; and

WHEREAS, pursuant to Section 4, Education Program, Subsection d, Goals, Objectives, Pupil Performance Standards of the Agreement states as follows:

The Charter School shall pursue and make reasonable progress toward the achievement of the goals, objectives and pupil performance standards consistent with those set forth in the Application and this Agreement, provided that such goals, objectives and pupil performance standards shall at all times remain in compliance with Section 2-3.64a-5 of the Illinois School Code, (105 ILCS 5/2-3.64a-5).

WHEREAS, pursuant to Section 4, Education Program, Subsection f, Curriculum of the Agreement states as follows:

The curriculum established by the Charter School shall be in accordance with the Illinois School Code, as applicable to public charter schools, and shall be consistent with the Application as otherwise modified or supplemented herein. The Charter School shall notify the Board of any material change in its curriculum subsequent to the date of this Agreement.

WHEREAS, the Board of Directors of RCSO wishes to suspend curriculum program services for sixth, seventh, and eighth grades in an effort to provide strengthened curriculum program services to kindergarten through fifth grade at Jackson Charter School; and

NOW THEREFORE BE IT RESOLVED, by at least a majority of the Board of Directors of Rockford Charter School Organization as follows:

1. The above-recitals are incorporated herein and made a part hereof.
2. That RCSO suspends curriculum program services for sixth, seventh and eighth grades and only provide curriculum program services for kindergarten through fifth grade at Jackson Charter School.
