- 6. Executive Director's Report
  - a. Executive Director Emily Wallen informed the Board that one of the paraprofessionals resigned on June 7<sup>th</sup>, but other than that, there have been no other staffing changes and the building is still fully staffed.
  - b. Director Wallen explained to the Board that in the preliminary assessment data, math stood at 2% and ELA stood at 11%. This is comparable to the previous 3% in math and 15% in ELA.
  - c. Executive Director Wallen informed the Board that 42 students are currently attending summer school. Transportation has been an issue because of how spread out the students are in Rockford.
- 7. Finance Committee Report
  - a. YTD Budget to Actuals
    - i. Finance Director Rick Aylward informed the Board that expenses were about \$550,000 over budget, the expenditures were about \$200,000 under budget and about \$350,000 in solitude.
  - b. YTD Cashflow Update
    - i. Finance Director Rick Aylward explained that the bank account contains a little over 2.5 million dollars. He stated that the charter is in good shape and is around the amount of money he predicted to be present at the end of the year.
